

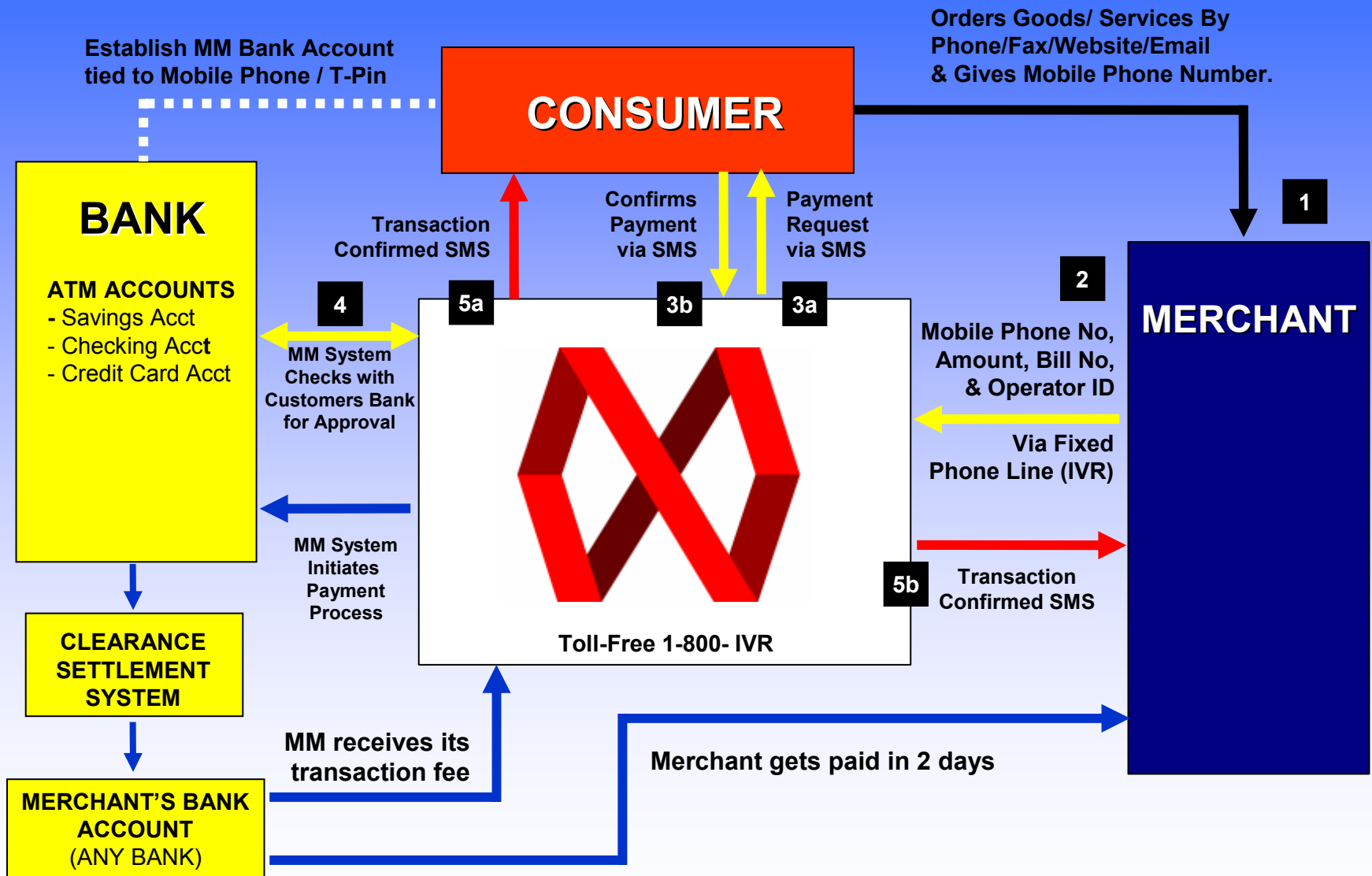

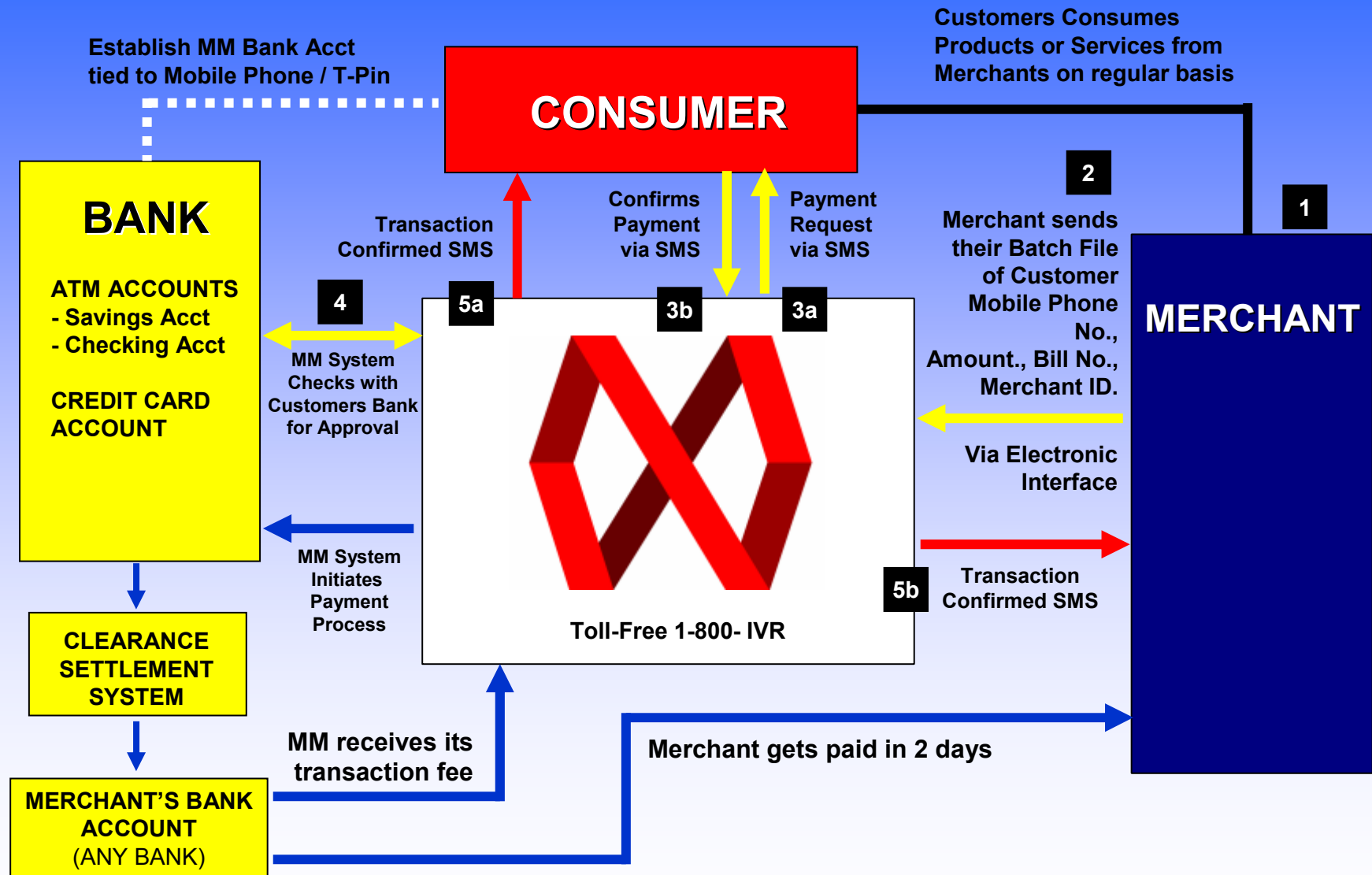
PAYMENT MODE 1 - REMOTE PAYMENT

REQUESTED BY MERCHANT VIA FIXED PHONE LINE (IVR)



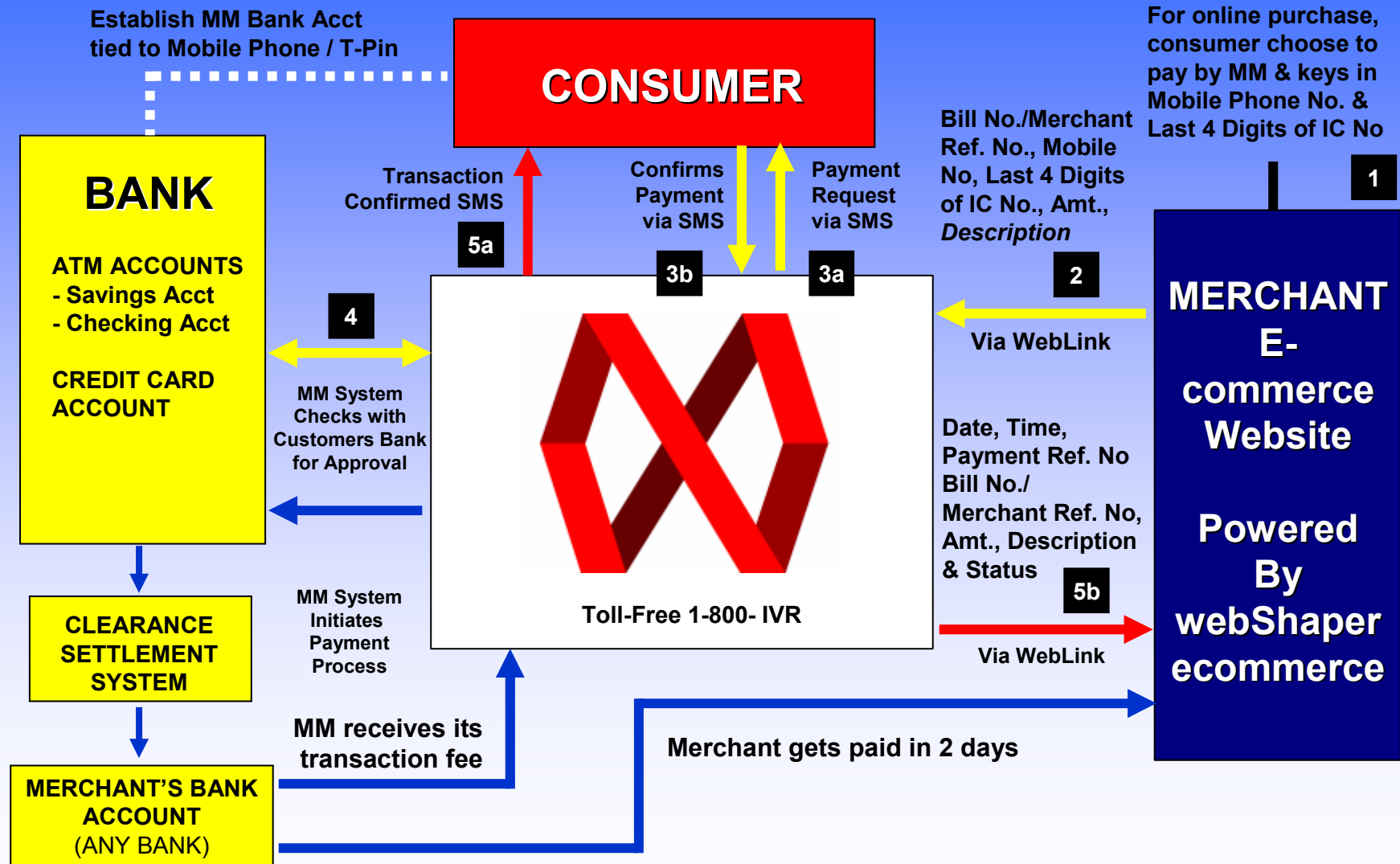
PAYMENT MODE 2 – BATCH REMOTE PAYMENT

- Complete Merchant Application Form and Agreement
- Pay RM100 (For Retailers) or RM300 (For Corporate) one time registration fee. Charge after first 10 transactions.
- Pay RM10.00 stamping fee. Charge after first 10 transactions.
- Need Letter of Authorization from a Director/Partners
- Need 1st page of Bank Statement for verification
- Need a Mobile Phone number tied to Merchant ID account
- Approvals will be notified via SMS. Upon successful signup, you will receive a Merchant Kit consists of Startup Guide, Merchant Guide, MMSOS Directory and Stickers.
